1. Purpose

This agreement sets out the terms under which the Mentee is trained and supervised by the Mentor in the installation, maintenance, and servicing of LPG systems in compliance with the Occupational Health and Safety Act (Act 85 of 1993), the Pressure Equipment Regulations (PER), and SANS 10087-1.

2. Roles & Responsibilities

2.1 Mentor

- Provide technical guidance and mentorship to the Mentee.
- Ensure that all work undertaken by the Mentee complies with relevant regulations and standards.
- Be actively involved in the installation process, including design, inspection of workmanship, testing, and commissioning.
- Take full responsibility for issuing the **Certificate of Conformity (CoC)** where applicable.
- Retain full accountability for compliance and safety of installations performed under this agreement.

2.2 Mentee

- Perform installation tasks as delegated by the Mentor under supervision.
- Follow instructions, work safely, and comply with all applicable SANS codes and company policies.
- Not issue or sign Certificates of Conformity.
- Accept that all work must be inspected and approved by the Mentor before completion.

3. Supervision

- The Mentee may undertake routine installation tasks (e.g., clipping pipes, trenching, appliance placement) independently, provided the Mentor has given prior instruction.
- The Mentor must be present for **critical points** of installation (e.g., pipe routing approval, leak/pressure tests, commissioning).
- The Mentor retains the right to stop, amend, or redo any work deemed non-compliant.

4. Liability & Indemnity

- The Mentor assumes final legal accountability for installations under this mentorship.
- The Mentee agrees not to perform any unsupervised or independent gas work outside this agreement until formally registered with SAQCC Gas.
- Should the Mentee perform any gas installation work outside the scope of this
 agreement or without the knowledge and approval of the Mentor, the Mentee shall bear
 full legal and financial liability for such work.
- The Mentee hereby indemnifies and holds the Mentor harmless against any claims, damages, losses, fines, or legal actions arising from gas-related work performed without proper supervision or authorization.

5. Duration

This agreement shall remain valid until terminated in writing by either party or until the Mentee obtains SAQCC Gas registration.
